Behaviour, however, depends on his attitude. The attitude in turn is influenced by defects as well as virtues. Personality defects are detrimental to an individual's happiness-contentment while virtues complement it. Personality defects make an individual's life stressful. An individual's personality defects are detrimental to society as well as Nation. This in turn adversely affects personal life too. In nut shell, PDR and inculcation of virtues is necessary to lead a happy and peaceful life.

It is a normal practice to intellectually understand the underling science before attempting something new. It helps us comprehend the importance better. Anything done with the knowledge of the underlying science takes place with greater interest, resulting in it being more effective. By understanding the immesurable harm caused by personality defects, the benefits obtained at various levels upon their elimination and inculcation of virtues helps us effectively impress upon our mind the importance of the PDR process and inculcation of virtues.
